Extracts from the Secretary's and Treasurer's reports:

The secretary reported on conference organisation and other tasks during the year. Following a steep decline in the number of submitted papers in 2005 compared with the previous five years, there has been a significant recovery in 2006: 71 submissions (52 in 2005). The increased tendency of foreign contributors to withdraw, having had their papers accepted, was noted. The work done by DCU for the 2005 conference local organisation was noted, as were the preparations made by the ESRI for 2006.
