2009 IEA MEMBERSHIP SUBSCRIPTION RATES: ANNOUNCEMENT

A new initiative by the *Economic and Social Review* to publish a policy-paper section is being supported by the

Irish Economic Association, both editorially and financially. The IEA's resources will have to be increased to meet this new commitment. While this may not seem to be an auspicious time to increase subscription rates, we should point out that these have not increased for almost 20 years. Moreover, the current economic circumstances have enhanced the need for the publication of timely and policy-relevant research.

Academic corporate members are being contacted separately about the new financial arrangements. For individuals, the subscription rate for 2009 will be increased to 60 (Stg£50), and this will include a subscription to the newly-augmented *Economic and Social Review*. The subscription renewal forms currently being sent to individual members will reflect these changes.

THE ECONOMIC AND SOCIAL REVIEW: ANNOUNCEMENT

A note from Professor Karl Whelan, Editor, ESR.

Since its establishment in 1970, the *ESR* has published original academic research. However, starting this year, the Review will also publish policy-related articles. The articles in the policy section will be distinct from regular *ESR* articles in being focused, not on developing new academic findings, but on using existing research and other evidence to contribute to debates on key issues related to economic and social policy. The articles should be evidence based, rather than opinion pieces, and will go through a full refereeing process.

The need for a forum for academic debate on policy issues has long been recognised in other countries. In the US, there is a wide range of different publications that meet this need, such as the *Brookings Papers on Economic Activity*. For the UK, there is also a range of such publications, such as the *Oxford Review of Economic Policy*. In recent years we have also seen new developments in other countries to meet this perceived need.

In smaller countries, it is more difficult to run a publication which is restricted purely to policy because there are fewer professional economists and social policy analysts working on domestic policy issues and the smaller scale makes it difficult to support successfully multiple outlets for relevant policy papers of good quality. However, in such countries there is still a need for at least one high quality forum for papers on economic and social policy that will provide proper quality control through a peer-review process. This is particularly true for Ireland at this point in its history. As we confront enormous economic and social challenges resulting from the sharp downturn in economic activity, there is

a clear need for careful analysis of public policy.

Previously, outlets such as the *Irish Banking Review* and the ESRI's *Quarterly Economic Commentary* provided outlets for policy-focused papers in Ireland. However, the *IBR* ceased publication a number of years ago. More recently, the ESRI communicated a desire to transfer its role in this area to a non-ESRI publication outlet. Given these developments, it seemed appropriate that the *ESR* should expand its remit to include the publication of policy-focused papers. This was discussed at the Councils of the *ESR* and the IEA during 2008, and a decision was reached to introduce policy papers into the *Review* starting this year.

In expanding the journal's remit, I would stress that the core value of high academic standards will remain and that the peer review process will continue to be rigorously applied.

DOCTORAL STUDIES IN ECONOMICS

Dublin Economics PhD

The TCD Department of Economics, the UCD School of Economics, and the NUIM Department of Economics, Finance & Accounting are launching a joint PhD programme in Economics. This programme, financed in part by the generosity of IRCHSS/GREP and SIF2/DRHEA grants, harnesses the strengths of the three institutions by providing students pursuing a PhD in Economics.

The programme will feature the combined expertise of the participating departments, a broad range of PhD level courses in both core and field areas, specialist research seminars, master classes conducted by local and international experts, skill seminars tailored specifically to needs, the possibility of inter-university supervision, and a large community of peers and colleagues.

Those interested in pursuing a Dublin Economics PhD can apply either to our individual programs through the usual channels, or directly to the Dublin Economics Programme. A website with additional information is under construction and will go live in March
