The 25th annual Irish Economic Association Conference will be held at the Radisson Blu Hotel, Limerick, from Thursday April 14th to Saturday April 16th The Central Bank of Ireland is undertaking the local organisation. A Call for Papers will be issued early in November, and will be posted on the IEA Website (www.iea.ie). The deadline for submitted papers will be mid-January, 2011. IEA Annual General Meeting, Stormont Hotel, Belfast, April 25th, 2010. Summaries of the Secretary's and Treasurer's reports:

The Secretary reported that 105 papers were submitted for the 2010 conference. This was below the 2009 submission level of 150, but was the 3rd highest since 2000. In addition the proportion rejected on qualitative grounds was one of the lowest recorded - 9%. The Association noted its thanks to the University of Ulster their valuable support in organising the annual conference. The Association has been successful in its effort to generate increased income, whihe has been used to support an extended *Economic and Social Review*.
